**WHEREAS**, Purchase Request No. ADMIN 2019-02-114 for the provision of Security Services from April 1, 2019 to December 31, 2019 was approved in the Annual Procurement Plan (APP) for CY 2019, with an Approved Budget for the Contract (ABC) of **Ten Million One Hundred Fifty One Thousand One Hundred Twenty Three Pesos and 85/100 (PhP10,151,123.85)**;

**WHEREAS**, the Project was posted in PhilGEPS for Public Bidding from 07 March 2019 until its closing period on 25 March 2019, in BAI website and in conspicuous places;

**WHEREAS**, only one (1) bidder, Star Special Corporate Security Management, Inc. submitted a bid proposal;

**WHEREAS**, Star Special Corporate Security Management Inc. bid proposal was subjected for evaluation of the BAI-TWG, End-user and BAC members;

**WHEREAS**, approved BAC Resolution No. 19-013 dated April 3, 2019 declaring Star Special Corporate Security Management Inc. as the bidder with the Single Calculated and Responsive Bid and was awarded for the said request;

**WHEREAS**, Notice of Award dated March 28, 2019 was prepared in the amount Ten Million One Hundred Fifty One Thousand One Hundred Twenty Three Pesos and 85/100 and was approved by the Head of the Procuring Entity dated April 3, 2019;

**WHEREAS**, the Notice of Award was posted in the PhilGEPs on July 25, 2019 in the amount of P5,460,041.82 instead of P10,151,123.85;

**WHEREAS**, upon inspection and review of all the documents attached to the said request, it was found out that an error was made in the amount indicated in the Notice of Award during posting at PhilGEPs;


